3 bids for website creation. Colleen Schneider volunteered to work on developing a township website which will have an annual hosting fee of around \$200.

Discussed Road Commission brine contract of \$14,682 for 3 applications. Bill for first application \$5,080.38 should have been \$4,894 which is 1/3 of contract amount.

**Motion** by Ryan, supported by Chapko to pay \$4,894 for first brine application to Montcalm County Road Commission. Carried.

**New Business:**

Fire contract \$17,773 with city.

**Motion** by Ryan, supported by Todd to approved Fire Contract with city of Carson City for \$17,773 to cover 7/1/14-6/30/15. Carried.

**Motion** by Schneider, supported by Ryan to adopt **Resolution #14-01** to submit ballot question regarding the township annual meeting for the November 4, 2014 election. Carried.

**Motion** by Ryan, supported by Chapko to allow up to a 4 working day waiting period for zoning permits if research is needed. Carried.
