The meeting was called to order at 8:00 PM by Supervisor Dan Ryan at Bloomer Township Hall, 9890 E. Carson City Rd, Carson City, MI. Present for roll call were Sarah Todd, Colleen Schneider, Larry Hummel, Tara Chapko, Dan Ryan.

**Motion** by Chapko, seconded by Hummel to accept the minutes of the May 18, 2015 regular meeting as presented. Carried.

**Fire Department Report:** Mark Crawfis reported.

**County Commissioner:** Betty Kellenberger reported.

**Citizens Comments:** Comments received regarding tall grass on roadside needing mowing.

**Clerks Report:** Sarah Todd

Correspondence reviewed, received sign estimate, working on FOIA policies.

**Motion** by Ryan, seconded by Todd to accept clerks report. Carried.

**Motion** by Chapko, seconded by Hummel to pay bills totaling \$5,524.50. Carried.

**Treasurers Report:** Colleen Schneider

Balance of \$287,383.87 in general accounts after bills. 2015 summer tax bills to be mailed July 1st, county treasurer wants township to take over perpetual care fund of \$1,460 which produced annual interest income of \$1.46, township declined.

**Motion** by Todd, seconded by Chapko to accept treasurers report. Carried.

**Zoning Administrator:** Duane Hagerman reported no activity.

**Cemetery Committee:** Ray Everingham installed 2 foundations, funeral pending.

**Unfinished Business:**

Old township hall has 2 offers, Seven Sisters \$42,650 and Montcalm Center for Orthopedic Excellence \$50,000. Both parties were informed of meeting and opportunity to raise offers. Seven Sisters raised their offer to \$52,000, Orthopedic sent no representative.

**Motion** by Chapko, seconded by Schneider to accept offer of \$52,000 from Seven Sisters to purchased old township hall. Carried.

**Motion** by Ryan, seconded by Todd to pay Montcalm Conservation District \$1,000 for services. Carried.

Mike Beach resigned May 25, 2015 as chair of the Planning Commission leaving an opening. Mark Ryan will attend the July 14 meeting before committing to membership. The Yard Sale Ordinance is still pending public hearing.

**Motion** by Ryan, seconded by Hummel to schedule public hearing for yard sale ordinance on July 14, 2015 at 6:30 PM. Carried.

**Motion** by Todd, seconded by Ryan to change Planning Commission wages from hourly to per meeting. Planning Commission members change from \$20 per hour to \$43.45 per meeting, secretary from \$25 per hour to \$53.45 per meeting and chair stays at \$100 salary per month. Carried.

**Motion** by Todd, seconded by Chapko to adopt Policy #15-01 Freedom of Information Act Procedures and Guidelines. Carried.
