

**Bloomer Township
Regular Meeting
June 20, 2016**

The meeting was called to order at 8:00 PM by Supervisor Dan Ryan at Bloomer Township Hall, 9890 E. Carson City Rd, Carson City, MI. Present for roll call were Sarah Todd, Colleen Schneider, Larry Hummel, Tara Chapko, Dan Ryan.

Motion by Hummel, seconded by Schneider to accept the minutes of the May 16, 2016 regular meeting as presented. Carried.

Fire Department Report: Mark Crawfis reported.

County Commissioner: Betty Kellenberger reported.

Citizens Comments: Comment regarding Grand Rapids Press article of May 22, 2016 regarding West Michigan populations. Discussed prison population and how each prisoner counts as half a person for Bloomer Township population.

Clerks Report: Sarah Todd

Correspondence reviewed. Preliminary ballot test completed, met with MTA Par Plan representative, informed city of partnering on recreation plan, city applied for wellhead protection grant, Todd volunteered to be on wellhead planning team.

Planning Commission: Doug Proctor reported next meeting July 12, 2016. Survey question answered for LandPlan, drafts of Master Plan sent to board and planning commission.

Zoning Administrator: Duane Hagerman reported swimming pool and deck removed on Garlock Rd. Any pool over 2 feet deep requires a permit from the county.

Cemetery Committee: Ray Everingham reported new cemetery sign installed, flags in for veterans, 2 burials.

Unfinished Business:

Michigan One Credit Union requires \$5.00 in a share account to open any other accounts. The interest rate is 1% on a CD and .45% on Money Markets.

Motion by Hummel, seconded by Chapko to authorize Colleen Schneider, Sarah Todd, Gary Schneider, Becky Proctor to be on the signature card at Michigan One Credit Union. A \$5.00 share account shall be opened so other accounts may be created. Carried.

New Business:

2 properties on Garlock Rd. in rural residential area were discussed. If the 2 parcels north and south of each other were combined and then split east and west into 2 parcels the home would be on one parcel and the business building on the other which could be converted to a home.

Discussed obtaining a flagpole from the school, discussed obtaining electric at cemetery or a solar light for a flag, discussed lighting for flagpole at hall and light to illuminate parking lot.

Complaint about dog referred to county animal control.
