The meeting was called to order at 8:00 PM by trustee Larry Hummel at Bloomer Township Hall, 9890 E. Carson City Rd, Carson City, MI. Present for roll call were Colleen Schneider, Tara Chapko, Dana Gonzales, Larry Hummel. Dan Ryan was absent.

Motion by Schneider, second by Gonzales to accept the minutes of the June 17, 2024 regular meeting as presented. Carried.

Fire Department: Mark Crawfis reported. 27 calls total for the year. Chief attended township and city council meetings. Also attended county TAC, fire association meetings and the County Emergency Mock Disaster Exercise on the 26th. Handled maintenance issues and ordered a digital camera for use at scenes. Cemetery Sexton: Issac Torres reported. Mowing and weed whipping. 2 foundations one for Russ Grinnell and one for Karl Harter.
